Anti-Ragging Policy

Definition of Ragging

For the purposes of this policy, ragging is defined as any act of physical or verbal harassment, intimidation, or abuse perpetrated by one or more students against another student. This includes, but is not limited to, actions such as:

- Physical assault or threat
- Verbal abuse, including derogatory comments and threats
- Inducing or coercing participation in humiliating or degrading activities
- Any other behavior that causes distress or harm

Objectives of the Policy

- 1. Prevent Ragging: To create awareness among students about the detrimental effects of ragging and to promote a culture of respect and camaraderie.
- 2. Ensure Safety: To ensure the physical and psychological safety of all students by implementing preventive measures and establishing clear reporting mechanisms.
- 3. Respond Effectively: To address incidents of ragging promptly and effectively, ensuring appropriate action is taken against offenders.
- 4. **Promote Inclusivity:** To foster an environment where all students feel welcomed, valued, and secure.

Preventive Measures

- 1. Orientation Programs: All new students will undergo orientation programs that emphasize the college's zero-tolerance stance on ragging and the importance of mutual respect.
- 2. Awareness Campaigns: Regular workshops, seminars, and campaigns will be organized to educate students about the consequences of ragging and the importance of a supportive community.
- 3. Counseling Services: The college will provide access to counseling services for students who may feel distressed or affected by ragging.

- 2. **Fair Process:** The investigation will be conducted in a fair and impartial manner, ensuring that all parties involved are given an opportunity to present their side of the story.
- 3. **Disciplinary Measures:** If ragging is confirmed, disciplinary actions will be taken against the perpetrators. These may include warnings, suspension, or expulsion, depending on the severity of the incident.
- 4. **Appeal Process:** Offenders have the right to appeal decisions made by the Anti-Ragging Committee. Appeals will be reviewed by an independent committee to ensure fairness.

Responsibilities of Students and Staff

- 1. **Students:** All students are expected to adhere to the Anti-Ragging Policy, report any incidents of ragging, and support their peers in creating a positive environment.
- 2. **Staff:** Faculty and administrative staff are responsible for monitoring student behavior, intervening in potential incidents of ragging, and supporting the implementation of the policy.

Review and Updates

The Anti-Ragging Policy will be reviewed periodically to ensure its effectiveness and to incorporate any necessary updates based on feedback, new regulations, and emerging best practices.
